Director, ICAR-NRCC, has accepted your offered rate of Service Charge Rs. 3.85% (including GST @18%) per month (on total wages including statutory liabilities such as EDLI, Admin Charges, EPF and ESIC, etc. {**please note: GST is not applicable on Agricultural related Farm labour work contract**}) as quoted by you in your financial bid subject to following condition:-

1. All terms & conditions and work details, as incorporated in the above referred GeM Tender Document, shall be strictly complied & adhered by you.
2. During the entire term of the Job Contract, you have to strictly ensure payment of monthly Minimum Wages to the labours (present rates are given on next page based on Agriculture rates w.e.f. 01.10.2023) deployed under the Contract, as prescribed/revised by Govt. of India, without any additional demand from ICAR-NRCC on account of service charge. However, any subsequent increase/decrease in statutory liabilities viz. minimum wages, ESI/EPF & taxes shall be reimbursed to the contractor. Also ensure payment of monthly Minimum Wages strictly as per the rates defined from time to time for the respective category of Labour/Job read with the Notifications issued by Govt. of India from time to time. Director, ICAR-NRCC, has accepted your offered rate of Service Charge Rs. 3.85% (including GST @ 18%) per month (on total wages including statutory liabilities such as EDLI, Admin Charges, EPF and ESIC etc. (please note: GST is not applicable on Agricultural related work contract)) as quoted by you in your financial bid subject to following condition:-

1. All terms & conditions and work details, as incorporated in the above referred GeM Tender Document, shall be strictly complied & adhere by you.
2. As per the terms & conditions of the Tender Document, you have to strictly ensure payment of Minimum wages to the Laborer deployed under the Contract, as prescribed/revised by Govt. of India from time to time (this Centre has adopted Agricultural rates and the present rates w.e.f. 01.10.2023 for Skilled labour is Rs. 523.00 per day, Semi-Skilled labour is Rs. 482.00 per day, and Un-Skilled labour is Rs. 438.00 per day), without any additional demand from NRCC. AGREEMENT TO BE ENTERED BY THE CONTRACTING AGENCY

The Agreement is made at Jorbeer, Bikaner on 0.11.2023 (month/year) day of between ICAR-NRC on Camel, Bikaner (hereinafter called Centre) through Director (Designation of the competent authority in the Centre) which terms shall include its successors, assignees etc. on the first part and M/s Shree Godara Construction Company, 412, Meghwalon ka mohalla, Nalbari, Bikaner – 334 001 (Raj.) (name & address of the "Firm") (hereinafter called the Firm) which terms shall include its authorized representatives, successors, assignees, etc. on the other part.

Whereas the NRC on Camel, Bikaner (Centre), has decided to assign the **ANNUAL JOB CONTRACT FOR SERVICES/JOB OF OUTSOURCING OF AGRICULTURE RELATED FARM LABOUR SKILLED, SEMI-SKILLED AND UN-SKILLED IN THE OFFICE/ FIELD/ ESTATE/ AGRICULTURE FARM/ LABORATORIES AND DIFFERENT UNITS ETC. AT NRCC, BIKANER** at the offered rate of Service Charge Rs. 3.85% (including GST @ 18%) per month to the Firm on the terms and conditions hereinafter contained.

NOW IT IS HEREBY AGREED by and between the parties hereto as follows:

1. The Agreement shall come into force w.e.f. 01.11.2023 and will initially remain in force for a period of one year in r/o of Job of the Schedule-I attached but can be terminated by either side by giving one calendar month's notice in writing of its intentions to terminate the Agreement. However, initially contract will be awarded only for 3 months and it will be extended for further period by the Director, ICAR-NRCC, Bikaner, if the service provided by the Agency is found satisfactory.
2. The firm shall be responsible for Job work contract for providing and satisfactory execution of jobs as per Schedule-I (enclosed) at NRC on Camel, Jorbeer, Bikaner
3. All personnel posted at premises shall all times and for all purpose be deemed to be employee of the firm and the NRC on Camel, Bikaner, shall have no liability on this account in any manner.
4. That the Firm shall ensure that all persons deployed at NRC on Camel, Bikaner, premises are of good character, well behaved and otherwise competent and qualified to perform the work for which they are deployed.

...shall have the right to ask for the removal from the ICAR-NRC on Camel, Bikaner, premises any personnel considered by the NRC on Camel, Bikaner, to be incompetent, disorderly or any other reason and such person shall not again be deployed without the consent of the NRC on Camel, Bikaner.

6. The Manpower deployed by the Agency should work as per the working days and timings of the NRC on Camel, Bikaner. No extra wages will be paid for attending office on weekends, holidays and late-sitting, if any.

7. Monthly consolidated charges for Job/Service contract for execution and providing of job/services as per attached Schedule-I at ICAR-NRC on Camel, Jorbeer, Bikaner, is as per terms and conditions specified and scope of work as Schedule-I in the tender document including all the taxes viz. Service tax and other taxes as applicable will be paid to the firm by the Centre. The firm will raise separate bill of Job given in attached Schedule-I for the specified amount on 1st working day of every month and the payment shall be released by the Centre through e-banking system to the firm subject to satisfactory performance/delivery of contracted job/work/services. Copies of documents such as deposit challan alongwith list of persons showing deposit of ESI, EPF, Service Tax etc. with the concerned Agencies are also to be deposited with the bill.

8. The Monthly Consolidated Charges, also include cost of each and every item including material cost (including कुल्हाड़ी, गैची, कस्सी, खुरपी, कड़ाई, फावड़ा, तगारी, बेलचा, दंताली, चौसंगी इत्यादि सामान), transportation cost, manpower cost and taxes etc. The NRCC shall not bear any extra charge on any account whatsoever including Income Tax, Uniform, Liveries, OTA etc., if any. The Agency shall be wholly responsible for making payment of monthly wages and all other admissible allowances to the personnel. Minimum wages, as prescribed from time to time shall be payable to the personnel deployed by the Agency for services to this Office. However, any subsequent increase in statutory liability viz. minimum wages, ESI, EPF and Taxes etc. and its consequential effect on EPF & ESI contributions and Service Charges shall be reimbursed to the contractor by NRCC, Bikaner.

9. The deduction of Income Tax from the bills of the Agency will be made at source as per rates and rules of Govt. of India, applicable from time to time.

10. In case of dispute between the parties, the matter shall be referred to the sole Arbitrator appointed by the Director, ICAR-NRC on Camel, Bikaner. The decision of the sole Arbitrator shall be final and binding in any respect of any dispute between the parties.

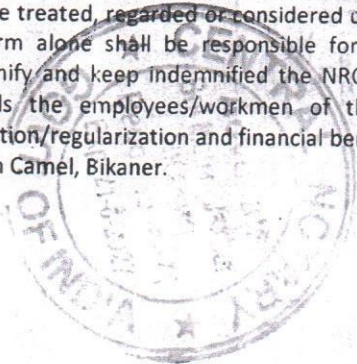
11. That the firm shall issue identity card to each of the worker engaged for entry into NRC on Camel, Jorbeer, Bikaner, premises.

12. That the firm shall ensure the successful implementation of the terms and conditions of the Agreement by proper control and supervision of the work.

13. That in case the Firm fails to perform any of the terms and conditions of this Agreement or commits any breach of the contract, the NRC on Camel, Bikaner may cancel the contract, at any time.

14. That the Firm(s) agrees to discharge all their legal obligations in respect of their workers in respect of their wages and service conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time, viz obligations under Contract labour (Regulation & Abolition) Act. 1970, Workmen's Compensation Act, 1943, EPF, E.S.I. & M.P. Act. 1947 etc. Firm agrees to indemnify and keep indemnified the NRC on Camel, Bikaner on account of any failure to comply with the obligations under various laws or damage to NRC on Camel, Bikaner due to acts/omissions of Firm.

15. It is also agreed that under no circumstances the volunteers and/or the employees/workmen of the Firm shall be treated, regarded or considered or deemed to be the employees of the NRC on Camel, Bikaner and the Firm alone shall be responsible for their remuneration, wages and other benefits etc. Firm shall indemnify and keep indemnified the NRC on Camel, Bikaner against any claim that it may have to meet towards the employees/workmen of the Firm. Firm's employees/workmen shall have no claim to absorption/regularization and financial benefits etc. that are admissible to regular employees in the Office of NRC on Camel, Bikaner.

16. The contract is subject to the conditions that the firm shall comply with all the Rules, Acts and bye-laws of Govt. of India and Govt. of Rajasthan, as applicable relating to this Contract.
17. In case of any loss or damage to the property of the Centre/Council which is attributable to the firm, the full damages will be recovered from the firm.
18. The Firm shall not transfer its right or sub-contract to any one else.
19. The firm or its workers shall not misuse the premises allotted to them for any purpose other than for which contract is awarded.
20. The Firm shall devote its full attention in service to ensure highest quality in all aspects and discharge its obligations under the contract with trust, diligently and honestly.
21. In case of any accident/loss of life of the workers during discharging duties compensation to be given to the workers, the same shall be borne by the Firm.
22. There will be surprise checking by an Officer, shortcomings, if any pointed out by him shall be restored by the Firm/ contractor within 01 hours of its bringing to his notice.
23. The firm shall provide a Co-ordinator for immediate interaction with the NRCC.
24. All the terms & conditions as stipulated in the tender document No. NRCC/ADM/P/I(02)/P/Job contract/2023-2024 dated 19.06.2023 and GeM Bid No. GEM/2023/B/3599495 dated 21.06.2023 of ICAR-NRCC, Bikaner shall be part of this Agreement.
- 25. ANY ACCIDENTAL DEATH/PERMANENT DISABILITY:**
During the term of the contract if any accident occurred, the Agency/firm/contractor shall be responsible to pay Rs. 10.00 lakhs in the event of Death or permanent disability resulting from loss of both limbs Rs.7.00 Lakhs in the event of other permanent disability as compensation to the deployed labour by you as per the guidelines issued by Govt. of India/Council vide letter No. Admn. 22(6)2018-Estt.III dated 31.07.2018 and subsequent guidelines issued from time to time

26. PENALTY CLAUSE: LIQUIDATED DAMAGES CLAUSE:

1. An amount of Rs.200.00 per day per Job will be levied as Liquidated Damage whenever and wherever it is found that the work is not up to the mark OR not executed in any Section. It will be brought to the notice of the supervisory staff of the Firm/Agency/Contractor, by NRCC and if no action is taken within one hour, liquidated damages clause will be invoked and shall be deducted / recovered from monthly bill(s)/Security Deposit of the Firm/Agency/Contractor.
2. Any misconduct/misbehavior and un-lawful activity on the part of the manpower deployed by the Agency will not be tolerated and such person(s) will have to be replaced immediately.
3. If the required number of Workers are less than the minimum required then as a Penalty of Rs.200.00 per worker per day will be deducted from the bill.
4. In case of any Loss or Damage etc. occurred to the movable or immovable property of the Centre due to any act or negligence of the Worker(s) deployed by the Firm/Agency/Contractor for execution of Job/Services as per Schedule-I, the said Loss/Damage etc. shall be recovered from the Firm/Agency/Contractor either from monthly bills or Security Deposit.

The decision of Director, NRC on Camel, Bikaner shall be final and binding on the Firm/Contractor/Agency in respect of any clause covered under the contract and any matter incidental to the contract.
