





3. The selected agency shall render the services Job work as per the specific instructions of the Centre. If service rendered by them is not satisfactory the contract will be terminated immediately, by the Centre.
4. The Firm shall complete the work, mentioned in the work order to be issued by ICAR-NRCC, Bikaner. Any delay or inability to complete ordered work have to be intimated immediately. No further extension will be allowed. However, if the firm fails to any or all of the work or perform the services within the time period(s) specified in the work order/contract, the purchaser (ICAR-NRCC, Bikaner) shall without prejudice to other remedies like cancellation of work order, contract and debarring from future procurement. 6. The Director, ICAR-NRCC, Bikaner reserves the right not to enter or accept Contract anytime. The selected Agency/contractor will have to make an agreement on the non-judicial stamp paper of appropriate value in favour of The Director, National Research Centre on Camel, Bikaner, within 15 days from the date of acceptance of the tender and thereafter, the work order/contract for the works/services will be awarded. The amount of Security money is 5% of the total value of the work is refundable after completion of the job, but in case the contractor fails to abide by the terms and conditions of the contract, the same is liable to the forfeited and the work of the ordered /services will be made from other sources at the cost and risk of the Contractor/Agency. The excess payment and other expenditure which the Centre will have to incur in doing so, will be recovered from the agency/contractor from his pending bills and other payments due to him. If the same will fall short of the amount to be recovered the same will have to be deposited by the contractor. In case any dispute regarding this contract arises the same will be referred to the arbitrator and the decision of the Arbitrator will be binding.


