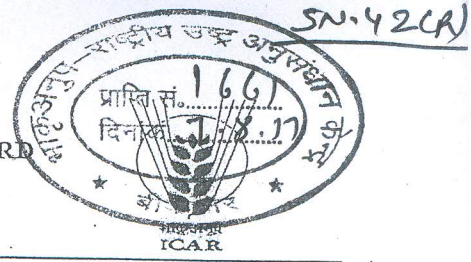

Sub : Recruitment Examination for the post of Lower Division Clerks (LDC's) in the Institutes of ICAR.

Sir,

The Board has been given the responsibility of conducting a common competitive examination for filling up positions of Lower Division Clerks in 63 research Institutions of the Indian Council of Agricultural Research (ICAR). The Board had earlier decided to hold the common examination on the 11<sup>th</sup> Decemeber, 2016 in conventional mode (by using OMR sheets) at 32 exam centres located all over the country. However, due to some administrative reasons, this exam was postponed and it was decided that the Board would conduct a common examination through computer based on-line mode on a fresh date and time to be notified. All concerned were accordingly informed about this decision through ASRB's notice vide No. 5(1)/2016-Exam I dated 28/10/2016, which was published in the leading National Newspapers and was also displayed on ASRB/ICAR website [www.asrb.org.in](http://www.asrb.org.in) / [www.icar.org.in](http://www.icar.org.in) and in websites of the participating institutes.

It has been now decided by the Board that the said common examination through computer based on-line mode shall be conducted on **10/09/2017 (Sunday)** at various exam centres across the country. For this purpose, the Board needs to prepare a common data base of all the candidates in online mode.

Accordingly, a Notice vide No. 5(1)2016-Exam I dated **21/07/2017** to be responded by the applicants of this examination has been prepared and placed on the ASRB/ICAR website [www.asrb.org.in/www.icar.org.in](http://www.asrb.org.in/www.icar.org.in) . This is also being advertised in leading National daily Newspapers.

You are requested kindly to place this notice also on the official website of your Institute with a link to the ASRB/ICAR websites to enable the candidates fill up the requisite details/application online. If required, the Notice dated **21/07/2017** may also be published in the local daily Newspaper.

Further instructions regarding the process of examination will be issued separately after the process of registration online is complete.
